Statement to Regulation (EC) No 1907/2006 (REACH)

According to the REACH regulation and as defined by the European Court of Justice¹ the products we supply are assembled articles.

In accordance with the roles defined under REACH, MTM Power® is a producer of articles and acts as a "downstream user" and is not subject to registration under Article 6. Furthermore, no substances are intended to release under normal or reasonably foreseeable conditions by use of our products and consequently MTM Power® doesn't have the obligation to register substances in articles referred to Article 7 (1). Substances and preparations which are added to our products as manufacturing auxiliaries are exclusively from European suppliers and have been registered respectively pre-registered through them. For such substances and preparations, the safety data sheets are available in accordance with the REACH regulation. Still, MTM Power® exclusively produces non-chemical articles and is therefore not subject to provide safety data sheets.

MTM Power® knows the obligation to communicate information on substances in articles in accordance to Article 33 of the REACH regulation, if a product supplied by us contains a substance of very high concern (SVHC) in a concentration above 0.1% by mass. We also regularly monitor changes to the REACH regulation. In particular, updates to ECHA's candidate list of SVHC and the substance restrictions and prohibitions in Annex XIV and XVII are continuously assessed.
